The purpose of the Hearing is to address the application reviewed by the Delaware Department of Insurance pursuant to 18 *Del. C.* § 5003(d) regarding the acquisition of control of or Merger with a Domestic Insurer Hamilton Select Insurance Inc. by Magnitude Master Fund, a sub-trust of the Magnitude Master Series Trust, a Cayman Islands unit trust, Magnitude Institutional, Ltd., a Cayman Islands exempted company, Magnitude Partners Master Fund, L.P., a Delaware limited partnership, Magnitude Insurance Master Fund, LLC, a Delaware limited liability company, Magnitude Capital, LLC, a Delaware limited liability company, Benjamin S. Appen and James M. Hall. The docket number assigned to this matter is 5183-2023.

The Hearing will be conducted in accordance with the Delaware Administrative Procedures Act, 29 *Del. C.* Chapter 101. A party has the right to present evidence, be represented by Delaware counsel and to appear personally or by other representative. The Delaware Department of Insurance is obligated to reach its decision based on the evidence received.
